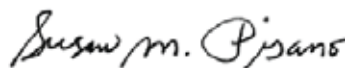

Introduction

About Health Literacy

According to the Institute of Medicine, health literacy refers to a person's ability to obtain, process, and understand basic health information and services so he or she can make appropriate health decisions.

People who understand health care information—medication directions, physicians' guidance, package inserts, instructions provided over nurse advice lines, and Web sites—are healthier. But patients who do not understand—and cannot act on—medical information and instructions, may face devastating effects on their health and well-being: poor control of chronic diseases, more hospitalizations and longer lengths of stay, improperly taken medications, and so on.

An estimated 90 million American adults suffer from “low health literacy,” 40 million of whom read below a fifth grade level. Stress, fatigue, and fear can make health literacy a challenge.

However, there is a growing awareness of the problem. The health care community and other stakeholders are beginning to address the challenge of clear health communication head-on. The first step is to help health care providers understand health literacy and its effects on outcomes and costs.

To help, Health Literacy Innovations, a social entrepreneurship company that creates tools to enhance health literacy, with support from the AmeriHealth Mercy Family of Companies, has introduced the nation's first comprehensive health literacy resource guide, the *Health Literacy & Plain Language Resource Guide*.

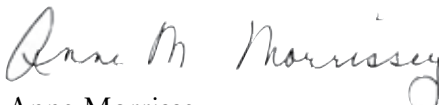

The HLA also scans and highlights hard-to-read and understand words by type of word (health and/or non-health) and flags long sentences. It is the only software product on the market that scrubs a document—ignores phone numbers, URLs, headings, and bullets—before it calculates readability, giving users an accurate readability score. The HLA also dutifully rewards writers for achieving a 6th grade reading level by inserting a “Reads Easy” stamp within their document for a job well done.

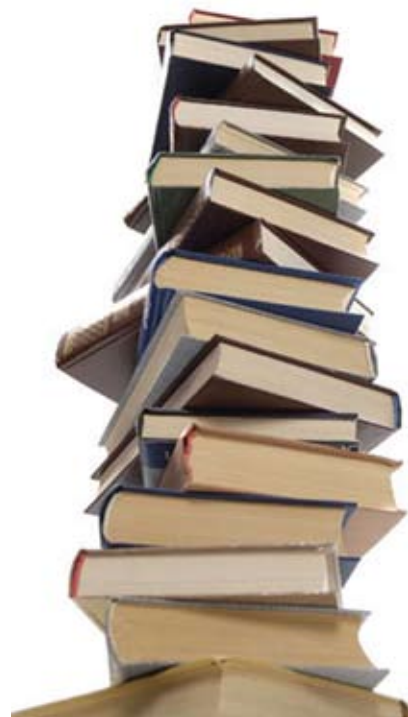

The HLA also scans and highlights hard-to-read and understand words by type of word (health and/or non-health) and flags long sentences. It is the only software product on the market that scrubs a document—ignores phone numbers, URLs, headings, and bullets—before it calculates readability, giving users an accurate readability score. The HLA also dutifully rewards writers for achieving a 6th grade reading level by inserting a “Reads Easy” stamp within their document for a job well done.

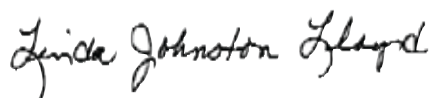

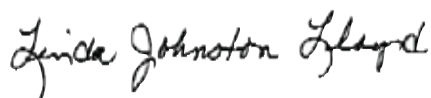
