## A. Subcommittee Updates-

# Healthcare Coordination/Operational Planning – Ann Brantley

Next Meeting Date - Thursday, September 10, 2009 at 3:00 p.m.

- An update was given on the recent Volunteer Symposiums that were held on 6-23/Dothan, 6-25/Huntsville, and 6-26/Montgomery.
- The ventilator triage document is in the final stages. The draft ventilator triage document has been finalized and is available at: <u>http://www.adph.org/CEP/assets/VENTTRIAGE.pdf</u>. The initial presentation of the document was piloted to the Alabama Society of Healthcare Engineering on May 15, 2009. Further presentations to the six hospital regions will be scheduled. The presentations will include ADPH environmental roles, legal and ethical issues, CEP assessments and tools, and the ventilator triage document explanation. These tools will serve to assist hospitals in emergency planning efforts.

- The County Emergency Support Function (ESF) 8 All-Hazards Assessment tool was developed by ADPH to aid each County Health Department in assessments of their ESF 8, healthcare, capabilities for pandemic and other all hazard situations and is located at <u>http://www.adph.org/CEP/assets/CountyESF8AllHazardsAssess3-</u>09.pdf. This will be used by the County Health Departments to obtain baseline county information that will be used to assist the counties in completing an initial gap assessment of their own ESF 8 healthcare response capabilities and shortfalls. ADPH is in the process of conducting these initial assessments. The first assessments for each county will be entered into the Learning Content Management System (LCMS) by July 31, 2009.
- Discuss/develop improved communication methods to get out messages to the public, especially in rural areas, during an event.
- There was discussion on the call regarding the planning needs for upcoming flu season vaccinations.
- The free personal protective equipment (PPE) and Comfort Care Centers (CCC) were discussed. Thus far, 42 organizations have participated in the PPE program; totaling supplies for 16,184 staff. There are currently two CCC's pending.

## Training and Exercise Planning – Valeria Patton

## Next Meeting Date - Wednesday, September 16, 2009 at 1:00 p.m.

The Emergency Preparedness (EP) Coordinators meeting was held on July 27, 2009. Exercise requirements for the 2010 grant year will include the following:

- One Full Scale Exercise Planning for this exercise is in the preliminary stages for Bibb County (ADPH Area 3). This exercise will include a "shelter in place" component.
- Table Top Exercise Based on a flood scenario and will be conducted in Chambers County (ADPH Area 6).
- Three Strategic National Stockpile (SNS) Drills These will be coordinated through DeeAnn White, ADPH SNS Coordinator, and John Hooper, ADPH, Cities Readiness Initiative (CRI) Coordinator. A meeting is scheduled for August 4, 2009 to discuss these drills.
- Six Table Top Exercises These will be held tentatively during February-March 2010 in the six Coroner Districts and will include a fatality management component.

# **Pharmacy Issues – Charlie Thomas**

# Next Meeting Date – Monday, September 14, 2009 at 1:30 p.m.

- The Jefferson County Health Department (JCHD) is working on a pilot study with CVS to develop mass dispensing plans.
- Caremark is a leading provider of prescription drug management programs. A Memorandum of Understanding (MOU) is in progress with Caremark to pre-fill prescriptions and label the medication minus

the patient's name. This will help to expedite distribution during a mass dispensing event.

- Mass Dispensing: Medications will have labels that will route the caller to either Auburn (AU) or Samford drug information centers, or the Alabama Poison Control Center (APC). Countermeasure Response Administration (CRA) system is the data submitted to CDC during an event. CRA has components for submission of adverse events resulting from pharmaceutical distribution during an event; discussion over how all support agencies will report this data is ongoing. The 800 number distributed on the medications will be answered by ADPH and partner agencies. There will need to be further coordination regarding the specifics on who, what, how, when, etc. of the data. Val Patton is the new CRA Coordinator for ADPH.
- MOU's are in place with Hyundai to be a designated alternate distribution site (closed POD). The next step is to exercise (tabletop) the MOU. Hyundai may be a role model for other alternate dispensing sites for a "Closed POD". This MOU can be utilized as a template for other businesses that have a health clinic within their facility.

#### Faith Based/Community and Other Volunteers Sector - Charlie Crawford

The 2009 volunteer symposia had approximately 400 attendees for the three venues. The evaluations were reviewed and volunteers requested more "hands on" and practical training on what ADPH will need volunteers to do in an emergency response. Planning has already started for the upcoming volunteers symposia. The Volunteer Symposia will reintroduce the ADPH Mobile Medical Stations. These stations are assets that ADPH has available at the central level as well as being pre staged throughout the state. The volunteer symposia would allow volunteers the opportunity to learn about the capabilities of the mobile medical stations and get a firsthand look at the facility. Also, the volunteer symposia would offer training to the Amateur Radio Volunteer Operators that will be utilized in a response. ADPH has been working with the hospital in Alabama to provide funding through the Hospital Preparedness Programs interoperable communications element. ADPH and the Alabama Hospital Association, and the American Amateur Radio Club have joined forces with the Hospital Amateur Radio (HAM) Program which provided funding for the purchase and the installation of HAM radios in most hospitals in the state. The symposia would help hospitals recruit licensed HAM radio operators to operate the radios. A final part of the first year's volunteer symposia would introduce the Family Assistance Centers that will be created in response to a mass fatality event. Continuity of Care and Post Disaster Care to families that have lost a family member to a mass fatality event is critical for the surviving family members. The volunteer symposia will provide training that will give volunteers the tools to help people get through the disaster. We had a meeting with the Governor's Office of Community and Faith-based Initiatives to discuss the utilization of Faith-based and Community Organizations with the planning process of forming

Family Assistance Centers that would be deployed in response to a mass fatality event. We also had a meeting with AARP, in which AARP introduced their new volunteer database and offered the system to any volunteer need that ADPH may have. We could post requests for volunteers and coordinate deployment and volunteer management with their association. The site was set up to help other underfunded partner agencies and organizations post volunteer needs.

- A meeting is scheduled for Wednesday July 28, 2009 with AEMA to discuss the clause in the Emergency Management Act that permits the AEMA to form "CORPS". The thought is to bring volunteers under this umbrella so that liability and workers compensation coverage could be extended to volunteers. John Wible discovered this possibility and will work with the AEMA legal staff to hopefully have this as a viable option.
- Work orders and system updates to the ESAR-VHP volunteer database continue to be implemented. The volunteer deployment module is close to being launched—this module will allow complete tracking of volunteer activities during a deployment.
- An email is being drafted to send out to ADPH volunteers to update their information in the Learning Content Management System (LCMS). At this time, we are not requesting volunteers, but we do want volunteers to update their contact information.

Dr. Jack Hataway retired in June 2009. He was an integral part of this committee and will be missed. This committee started in December 2006 and has made many strides toward improving the health and medical emergency response for the state. There is a long way to go in planning and we appreciate Dr. Geary, ADPH Medical Director for Bureau of Health Provider Standards, graciously agreeing to lead us in Dr. Hataway's absence. We look forward to working with Dr. Geary. Dr. Geary was introduced on the call and shared his professional experience with the group.

We are in the process of updating our database and membership of the Alabama Department of Public Health's Healthcare Sector Committee. Novel H1N1 (referred to as "swine flu" at its inception) is a new influenza virus causing illness in people. Novel H1N1 influenza virus was first detected in the United States in April 2009.

CDC has determined novel H1N1 virus is contagious and is spreading from human to human, probably in much the same way that regular seasonal influenza viruses spread, although it remains unknown how easily this novel H1N1 virus spreads.

Valerie Cochran mentioned that the Alabama Board of Nursing decided that licensed practical nurses (LPN) will not be approved to perform fit testing. ADPH will not perform fit testing for outside agencies.
