Charlie has reviewed program; may be limited in effectiveness in a pandemic influenza (PI) but useful for other hazards. Charlie pointed out there is no way to know what shortages there may be. Noted that the Emergency Management Agency (EMA) will also be involved in distribution and may utilize the Department of Transportation. Further discussion to follow about potential uses with logistics. The modeling software developed for SNS programs by the CDC is called Real Opt. Real Opt is designed to assist states in developing an alternate means of medication delivery to RDSs and PODs. Jim Barrett of Montgomery EMA is the RSS Manager for ADPH during a SNS activation.
