### **EMERGENCY MEDICAL SERVICES FOR CHILDREN**

Injury is the #1 cause of death in children. This year alone, 14 million children under the age of 15 will be injured seriously enough to require medical attention. These are tragic figures, especially since injuries are not accidents; they have predictable patterns, circumstances and at risk groups.

Fortunately, one of the keys to injury control is prevention. As prehospital professionals, you are in a unique position to be advocates for children and injury prevention throughout the state of Alabama. Some examples of injury prevention strategies include: the use of car seats, seat belts, motorcycle helmets, bicycle helmets, gated stairways, fire and smoke detectors, and pool alarms; discouragement of infant walkers and trampoline usage; and the proper storage of medications and poisons. Whether you address these issues on a one-on-one basis, in front of a large group, or by example, each of you can help make the difference in a child's life. Preventing injuries is so much easier than treating them.

Notify your Regional EMS Agency when your entire service is trained so that you can begin to use the new protocols!

FYI....a questionnaire that will be coming to your service very soon! It's imperative that this be completed and returned to our office as soon as possible. Your quick response is critical to the success of the implementation plan for our new software.

## **COMPLIANCE & INVESTIGATIONS**

Since June 1, 2007, the Office of Emergency Medical Services & Trauma has been involved in 9 new investigations.

- EMT- Basic, impairment license suspension
- EMT-Basic, HIPPA violation case turned over to Department of Justice, Office of Civil Rights
- EMT-Paramedic, crimes involving moral turpitude EMT license surrendered
- EMT-Basic, exceeded scope of practice (I.V. therapy & EKG recognition)-15 day suspension
- 4 other investigations involved service licenses- no licensure action taken
- 1 EMT-Paramedic investigation still on-going

Previous (prior to June 1) on-going investigations:

- EMT-Paramedic, student falsified clinical records 120 day suspension
- Ambulance Driver, guilty of crimes involving moral turpitude-license surrender
- Impairment voluntary and emergency suspension(s)

Reinstatement of license:

- Two EMT-Paramedics have each met all requirements under State EMS
- Rule 420-2-1-.21 Impaired EMTs and have been reinstated back to active status
