Shelby County EMT of the Year—Richard Smith, EMT-B. Richard was presented the award by Ben Kirkland of the Shelby County Fire & EMS Association. Ben read a letter from Captain David Lawthorne nominating Richard. "It is a continuing personal sacrifice of family and personal time that he completes his duties tirelessly, professionally and proudly. He gives 110% not just to collect a paycheck but to give back to his community. He drives us all to excel in what we do."



St. Clair County EMT of the Year—Tim J. Kurzejeski, EMT-P. Tim was presented the award by James Robinson of St. Clair County Fire & EMS Association. Chief Robinson had this to say about Tim: "Tim is a firefighter/paramedic for the City of Pell City where he's been since 1995. He also provides EMS in Riverside. He is a model for the younger EMTs in Pell City and Riverside and always sets the standards for and practices superior patient care. He also serves in the community as a CPR instructor for schools and businesses."


