



STATE OF ALABAMA
PROCLAMATION
BY THE GOVERNOR

WHEREAS, the State of Alabama was affected by severe thunderstorms, hail, straight line winds, and tornadoes which began on April 15, 2011, and I, Robert Bentley, Governor of the State of Alabama, did declare a State of Emergency, pursuant to Code of Alabama § 31-9-8 (1975 as amended), in the State of Alabama as a result thereof;

WHEREAS, on April 28, 2011, acting pursuant to §§ 31-9-1, *et seq.*, I issued a Proclamation declaring *in para materia*:

I, Robert Bentley, Governor of the State of Alabama, under the emergency powers and authorities granted to me by Chapter 9 of Title 31 of the Code of Alabama 1975, do hereby extend the time frame of said statute from seventy-two (72) hours to thirty (30) days. This extension shall apply to both instances where seventy-two (72) hours is set out in the statute. All other provisions of said statute shall remain in full force and effect. To the extent that *Code of Ala. 1975*, § 34-23-75 conflicts with the terms of this paragraph, the said statute is suspended or amended to be in compliance with this Order.


BE IT ORDERED, *Code of Ala. 1975*, § 34-23-70 notwithstanding, that non-controlled prescriptions may be refilled upon the presentation of the actual medication bottle indicating the name of the prescriber, copies of prescriptions, insurance billing report or insurance claim notification, or other documentation which would provide the pharmacist sufficient information to adequately identify the non-controlled medication and the dosage thereof. To the extent that *Code of Ala. 1975*, § 34-23-70 conflicts with the terms of this paragraph, the said statute is suspended or amended to be in compliance with this order; and,

WHEREAS, officials at the Alabama Emergency Management Agency, Alabama Board of Pharmacy and the Alabama Department of Public Health, have indicated that the aforementioned suspension, temporary modification or amendment of Alabama Law is no longer necessary.

NOW, THEREFORE, I, Robert Bentley, Governor of the State of Alabama, do hereby terminate the above identified Proclamation issued April 28, 2011, effective 12:00 noon on May 30, 2011.

BE IT ORDERED that the appropriate Alabama state agencies are hereby instructed to resume to their normal state of business and day-to-day operations unless such agency is assisting the affected communities in recovering from the storms.
